Further to an internal application made for the purpose of orphanage and aftercare for the abovementioned facility, I wish to advise that an inspection was made and the facility is in compliance to all standard requirements under Childcare Facilities as prescribed in terms of Part 4, Section 31 of the City of Cape Town: Environmental Health By-Law No13333, P.G. No. 6041, dated 30 June 2003.

The orphanage facilities can only accommodate a maximum of 36 children in total and the aftercare facility can accommodate a maximum of 80 children in total.
